

TERMS & CONDITIONS

- 1. Extinguisher should be based on water —CO2 solution.
- 2. Suppliers must have valid PAN and Valid GST No.
- 3. Rate to be quoted by the Organization/Agencies who primarily deal with similar type of work only. However, the undersign may take the liberty to choose any bid from reputed Organization/Agencies.
- 4. Supplier must have Fire license or Original Equipment Manufacturer (OEM) Fire license Certificate.
- 5. Supplier must have test certificate on fire extinguishing equipment such as IS/EN/PED/MED and should have similar nature of work credential.
- 6. Intending bidders shall have to quote the overall rate inclusive of all taxes.
- 7. The quotationers/Organizations/Agencies should have valid trade license from concerned authority.
- 8. The rate offered should be valid for 6(six) months. However, the same can be increased up to 1-year subject to satisfactory service of the quotationer.
- 9. Upon successful completion of the work to the satisfaction of the quotation inviting authority or his official superior, payment will be made on actual work, by the office of the Divisional Manager, Medinipur Forest Corporation Division.
- 10. Work order will be issued to the successful quotationer as and when required and subject to availability of fund from appropriate authority.
- 11. Any extinguisher in damaged condition, found to be broken or unserviceable not to be accepted.
- 12. Bills will be settled only after satisfactory supply, testing and quality material received.

13. A short training on handling of fire fighting equipments during fire hazard will be conducted by the L1 bidder before installing of equipments.
